## electrical training ALLIANCE of Western Oklahoma

Beginning with Class 1A of 2021, and for any class started thereafter, there has been an Associate's Degree Program established for the electrical training ALLIANCE of Western Oklahoma. This program is currently through Butler Community College of Wichita, Kansas. (Associates of Applied Science for Workforce Development)

All apprentices indentured by the electrical training ALLIANCE of Western Oklahoma will be required to complete this Associates Degree Program to complete their obligation to the electrical training ALLIANCE of Western Oklahoma and be reclassified as a Qualified Electrical Journeyperson of the International Brotherhood of Electrical Workers.

The electrical training ALLIANCE of Western Oklahoma will cover the cost of tuition and fees for all required courses. The tuition and fee amounts will be added to the Scholarship Loan Agreement and Promissory Note for each class cycle. It will be up to the apprentice to pay the book fees required to complete each course. Any apprentice that fails any course of the program will be required to retake that course, at their own expense. It will also be up to the individual apprentice to reschedule the class that is to be repeated.

Any apprentice that completes the required electrical curriculum of the electrical training ALLIANCE of Western Oklahoma, reaches or exceeds the appropriate number of on-the-job training hours and has obtained their Oklahoma State Unlimited Journeymen license, but has not obtained their Associates of Applied Science for Workforce Development degree, will have one calendar year after qualifying for their state test and the completion of the electrical curriculum. Failure to meet all the requirements as set forth above will result in the apprentice being reclassified into the CW/CE program until all requirements for advancement to Journeyman status are met.

Any apprentice that has been reclassified to the CW/CE program and who has not obtained their Associates of Applied Science for Workforce Development degree in the subsequent calendar year will be subject to repayment of all costs of the college program, in full, before they can advance to Journeyman status, after meeting all other requirements.
